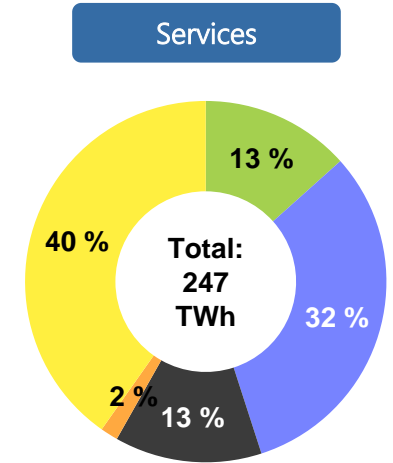
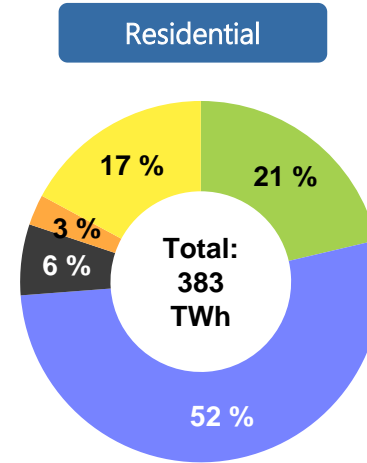
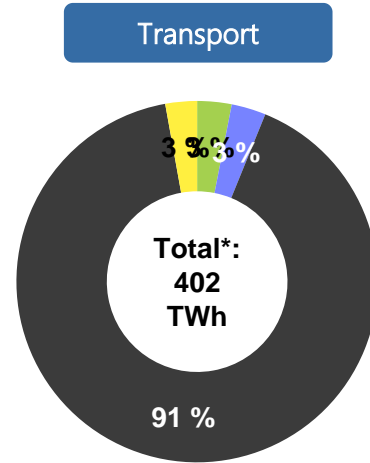
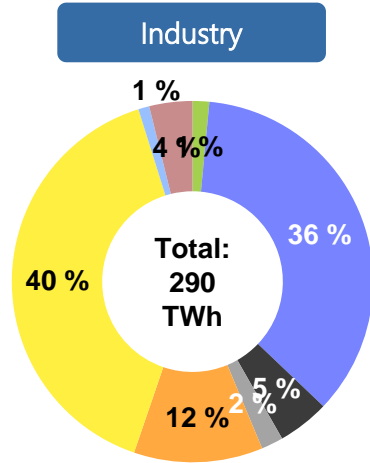
# Italy's Electricity Sector



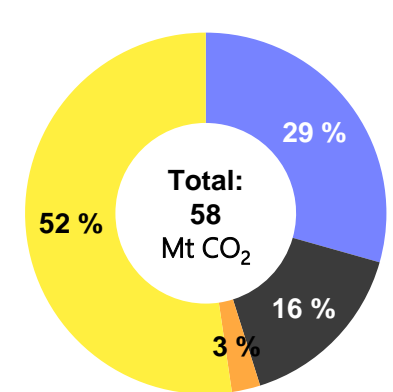
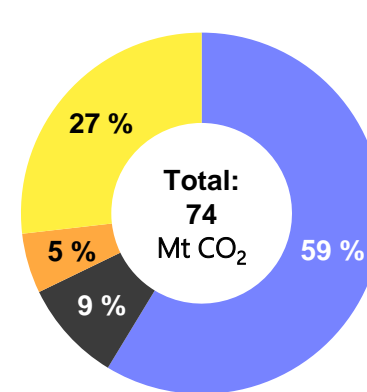
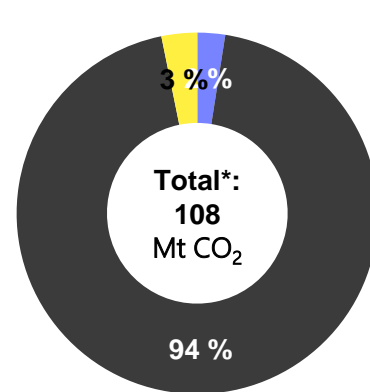
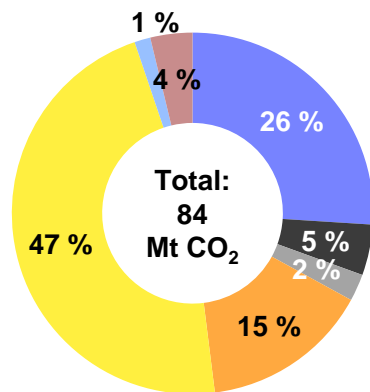

CO<sub>2</sub> - Emissions

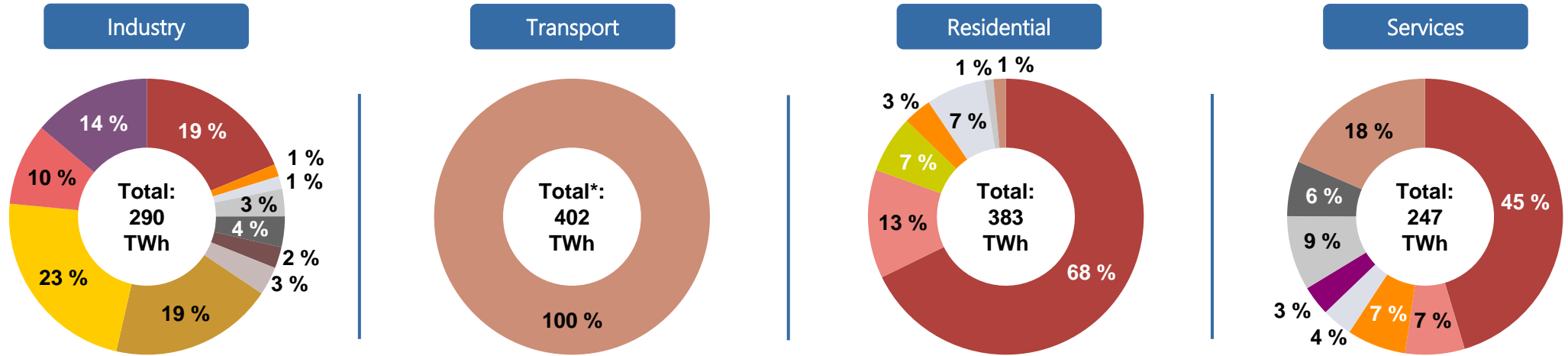

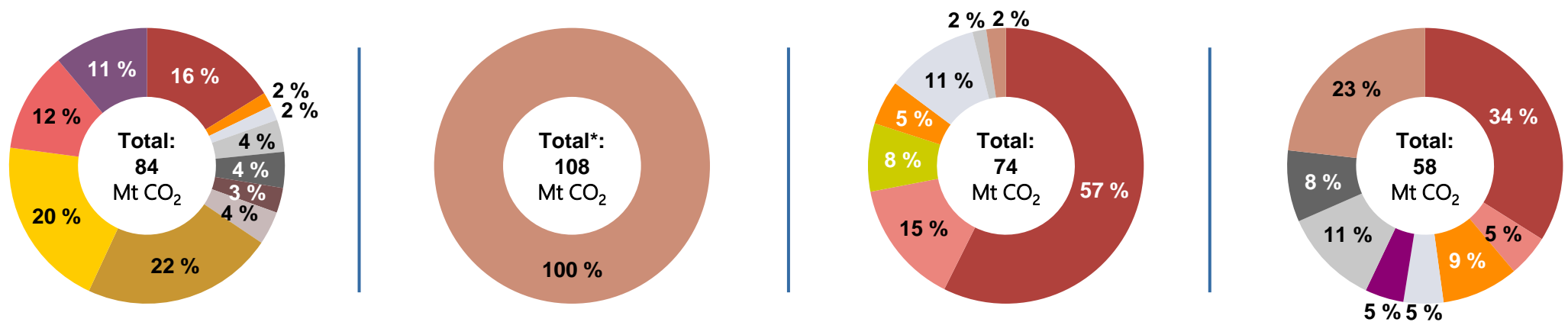
